

BLACKMAIL CONTRACT

Consensual Leverage & Controlled Exposure

PARTIES

Controller / Owner: Goddess Sanna

Subject / Property: _____

(hereinafter referred to as "the Subject")

PURPOSE

This Blackmail Contract grants Goddess Sanna consensual leverage over the Subject through the possession and potential controlled release of sensitive material, secrets, or information. The Subject willingly provides or acknowledges such material and accepts that Goddess Sanna may use the threat of exposure as a tool of control, motivation, and ownership.

CLAUSE 1: MATERIAL & LEVERAGE

1.1 Nature of Material

The Subject acknowledges that Goddess Sanna holds or may come to hold photographs, videos, written confessions, personal secrets, financial details, or any other sensitive information ("the Material"). This Material constitutes valid leverage.

1.2 Consent to Possession

The Subject consents to Goddess Sanna retaining, organizing, and potentially expanding the Material for as long as this Contract remains in force. The Subject will provide additional Material upon demand.

1.3 Controlled Disclosure Rights

Goddess Sanna reserves the right to threaten, prepare, or (at her sole discretion) execute disclosure of the Material if the Subject fails to comply with her instructions.

CLAUSE 2: OBLIGATIONS OF THE SUBJECT

2.1 Obedience Under Leverage

The Subject agrees that the existence of the Material creates a permanent incentive for total obedience. Any demand from Goddess Sanna — financial, task-based, sexual, or psychological — must be fulfilled promptly to avoid escalation.

2.2 Prohibited Actions

The Subject shall not attempt to recover, delete, or neutralize the Material, nor seek outside help to undermine Goddess Sanna's leverage. Any such attempt constitutes a severe breach.

CLAUSE 3: ESCALATION & EXPOSURE PROTOCOL

3.1 Breach Consequences

In the event of non-compliance, Goddess Sanna may, at her sole discretion:

- Increase the intensity or frequency of demands.
- Require additional compromising Material to be created and surrendered.
- Share selected portions of the Material with designated third parties or platforms.
- Publicly reference the Subject's submission and failures in ways that create real social pressure.
- Extend the duration or scope of the Contract.

CLAUSE 4: LEGAL & CONSENT

4.1 Voluntary & Informed Consent

The Subject signs this Contract freely, fully aware of the power imbalance being created. The Subject understands that the leverage is intentional and desired.

4.2 No Unilateral Termination

The Subject may not unilaterally revoke Goddess Sanna's possession of the Material or the rights granted herein. Only Goddess Sanna may release the Subject from this Contract.

4.3 Duration

This Contract remains binding until Goddess Sanna declares it ended. She may keep the Material indefinitely as a permanent reminder of ownership.
