

DEBT CONTRACT

Financial Enslavement & Tribute Obligation

PARTIES

Creditor / Owner: Goddess Sanna

Debtor / Property: _____

(hereinafter referred to as "the Debtor")

PURPOSE

This Debt Contract establishes a binding financial obligation of the Debtor to Goddess Sanna. All tributes, gifts, and payments demanded by Goddess Sanna shall be treated as partial repayment of the stated principal debt plus accruing weekly interest. The Debtor acknowledges that the debt exists solely at the pleasure of Goddess Sanna and may be increased at Her sole discretion.

CLAUSE 1: THE DEBT

1.1 Principal Amount

The Debtor hereby acknowledges and agrees to the principal amount stated above as an irrevocable financial debt owed to Goddess Sanna. This amount may be increased by Goddess Sanna at any time without notice or justification.

1.2 Weekly Interest

Weekly Interest Rate: _____ % / \$ _____

Interest accrues weekly on the outstanding principal (and any previously accrued unpaid interest). The rate or fixed weekly amount stated above applies automatically every seven (7) days until the debt is declared satisfied by Goddess Sanna. Unpaid interest is capitalized and added to the principal.

1.3 Tribute Schedule & Payments

The Debtor shall pay regular tributes as demanded. Frequency, amount, and method of payment are at the sole discretion of Goddess Sanna. All payments are applied first to accrued interest, then to principal. Failure to meet any demand within the stated timeframe constitutes default.

CLAUSE 2: EXTRA INCOME & REIMBURSEMENTS

2.1 Extra Income Redirection

Any bonuses, gifts, tax refunds, or unexpected income received by the Debtor shall be reported immediately and redirected in full or in part to Goddess Sanna within 24 hours of receipt. Such amounts may be applied to the debt or treated as additional tribute at Her discretion.

2.2 Reimbursement Liability

The Debtor assumes full responsibility for any expenses Goddess Sanna chooses to have reimbursed, including but not limited to luxury items, entertainment, beauty treatments, travel, or any other costs She incurs. These amounts are added to the principal debt.

CLAUSE 3: CONSEQUENCES OF DEFAULT

3.1 Default Protocol

Should the Debtor fail to pay any demanded tribute, interest, or gift on time, Goddess Sanna may impose any of the following at Her sole discretion:

- Immediate increase of the outstanding principal by any amount She chooses.
- Increase of the weekly interest rate or fixed weekly interest amount.
- Requirement of additional humiliating or degrading tasks as further "interest".
- Public or private exposure of the Debtor's financial submission and failures.
- Restriction of the Debtor's personal spending until the default is cured to Her satisfaction.
- Escalation into more severe forms of ownership and control.

CLAUSE 4: FINANCIAL CONTROL & CONSENT

4.1 Access & Transparency

The Debtor agrees to provide Goddess Sanna with full transparency regarding income, savings, and spending when requested. Goddess Sanna may demand screenshots, statements, or live verification at any time.

4.2 Voluntary Consent

The Debtor enters this Contract willingly and with full understanding of the principal amount, weekly interest, and all related terms. The Debtor recognizes Goddess Sanna's absolute authority over the debt.

4.3 No Recourse & Duration

The Debtor waives any right to dispute, reduce, or terminate the debt unilaterally. Only Goddess Sanna may declare the debt satisfied or the Contract ended. This Contract remains in force until She decides otherwise.
