

TOTAL POWER EXCHANGE CONTRACT

Complete Ownership of Body, Mind & Life

PARTIES

Owner: Goddess Sanna

(hereinafter referred to as "the Property")

PURPOSE

This Total Power Exchange (TPE) Contract irrevocably transfers all rights, autonomy, and decision-making authority of the Property to Goddess Sanna. By signing, the Property consents to the complete dissolution of free will in service to Goddess Sanna's desires, amusement, and ownership. The Property exists solely for Her use.

CLAUSE 1: TERMS OF SURRENDER

CLAUSE 2: FINANCIAL OWNERSHIP

2.2 Income & Expenses

Extra income, bonuses, and windfalls shall be reported and redirected as ordered. The Property may also be required to reimburse Goddess Sanna for any expenses She chooses.

CLAUSE 3: PHYSICAL & PSYCHOLOGICAL OWNERSHIP

3.1 Bodily Autonomy Termination

The Property's body becomes Goddess Sanna's exclusive tool. She may demand chastity, orgasm control, specific sexual acts, physical presentation standards, or any other use of the body.

3.2 Mental Conditioning

4.1 Voluntary Consent
